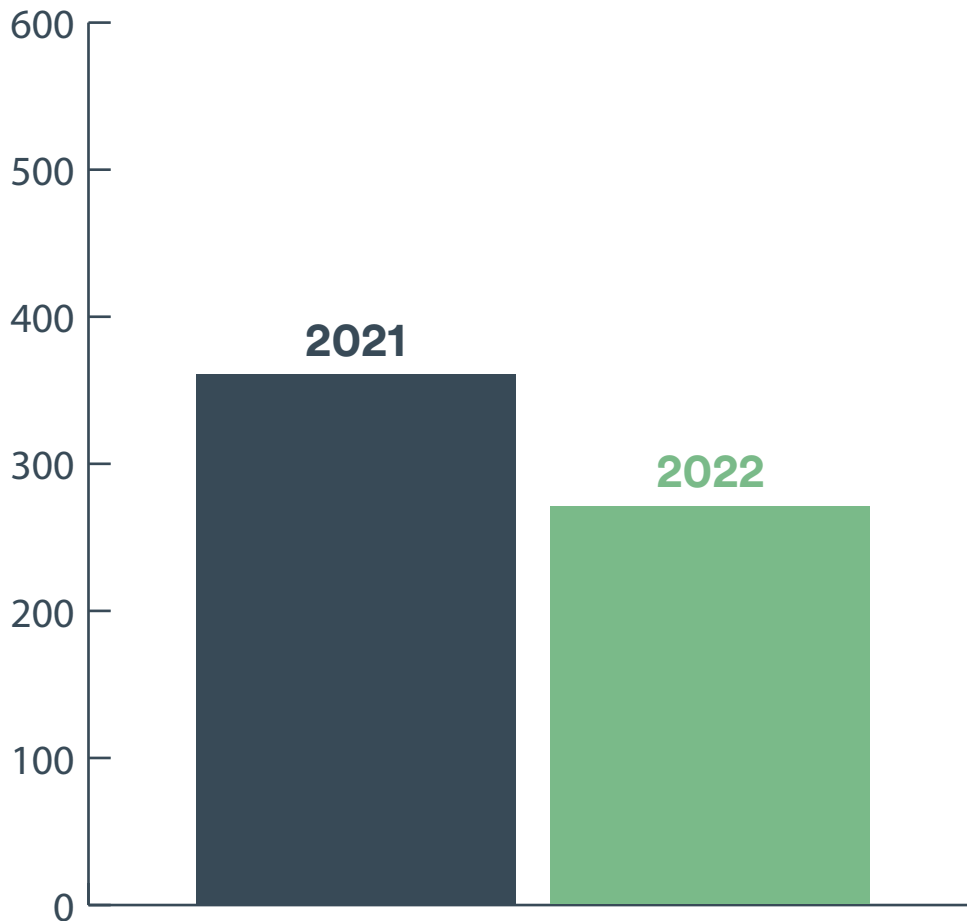




# 2022 School Leaders Survey

# RESPONDENTS:

**270 total respondents - compared to 359 last year - with a 64% completion rate.**



# KEY TAKEAWAYS:

**1**

Survey respondents to this year's survey are a bit more seasoned compared to last year's respondents: over 5.5% more respondents have been a school leader for over 20 years.

**2**

Over 58% of survey respondents perceive the state of education in their school district to be excellent or good. Over 55% think the same to be true of the current state of education in Tennessee as a whole.

**3**

In addition to the budget, staffing and scheduling issues, multiple survey respondents believed that too many "initiatives" and "strategies" from the district with no additional time to execute them were major limitations or constraints hindering their ability to improve student outcomes.

**4**

Compared to last year's survey, 51% more respondents feel that the teachers in their district are prepared to be effective teachers.

**5**

Unfortunately, 64% of respondents are unsure how their district's budgeting process will look differently under TISA compared to BEP.





**6** Of the learning loss strategies mandated by the state, multiple respondents suggested that the most impactful way to combat learning loss is to pay teachers more for the additional time and interventions they are implementing to combat learning loss or hire additional interventionists who can take those additional responsibilities from teachers.

**7** While almost 88% of respondents admitted they are seeing an increase in the number of students seeking mental health services compared to pre-pandemic, less than half (45%) feel as if they are able to effectively meet the needs of all students with a team of mental health professionals.

**Staffing:** 81.90% (+9.68%)

**Other:** 25.00% (+8.33%)

## Some of the most common “Other” responses:

- **Some responses referenced the impact negative parent involvement has had on schools.** Respondents also mentioned too many “initiatives” and “strategies” from the district with no additional time to execute them.

**YES:** 75.12% (+4.53%)

**NO:** 20.28% (-5.25%)

**Unsure:** 4.61% (-1.27%)

**<\$50,000:** 15.21% (+9.33%)

**YES:** 70.32% (+3.65%)

**NO:** 16.89% (-5.33%)

**Not applicable/I do not make student assignment decisions:** 12.79% (+1.68%)

Alternatively, when assigning students to classrooms, do you give consideration to the student's individual achievement levels from the previous year relative to the teacher/classroom performance where they will be assigned? (Ex: Student X is somewhat behind from the past year so they should be placed in one of your higher performing classrooms in the coming year.)

**YES:** 52.56% (-6.26%)

**NO:** 47.44% (+6.26%)

**If yes, was your finance and budgetary training focused more on budgetary compliance or how to use dollars to impact student achievement?**

**Compliance:** 48.15% (-8.99%)

**Both, but mostly compliance:** 42.96% (+21.53%)

**Strategy:** 2.22% (-4.92%)

**Both, but mostly strategy:** 6.67% (-7.62%)

**Do you receive an equitable amount of school funding based on the population of students you serve? (Ex. economically disadvantaged students, English language learners, special education students, etc.)**

**YES:** 51.16% (+9.98%)

**NO:** 39.07% (-13.87%)

**Depends:** 9.77% (+3.89%)

In the 2022 legislative session, lawmakers replaced the Basic Education Program (BEP), a resource-based formula, with the Tennessee Investment in Student Achievement (TISA) Act, a district-based funding formula. One goal with TISA is to empower district and school-level leaders to make funding decisions that best meet the needs of their students. When your school district begins the budgeting for FY24, how will your budgeting process look differently under TISA compared to BEP?

\*Respondents are asked to check all that apply\*

**I do not believe our district will change our budgeting process: 17.67%**

**Our district will be consulting with school leaders to inform many of our district's budgeting decisions: 22.79%**

**Our district will consider merit-based bonuses to recruit or retain the best educators: 7.91%**

**Our district will consider contracting with community-based providers for services that we may not be able to offer with district or school-level staff (i.e., behavioral specialists, school nurses, etc.): 5.12%**

**I am unsure: 63.72%**

Tennessee public schools are receiving over \$4.5 billion in federal relief funding for use between spring 2020 and fall 2023-- an historic influx of federal funding to support K-12 schools and students across the state. Of the learning loss strategies mandated by the state, which of the following strategies to combat learning loss do you think will be the most impactful in your district?

\*Respondents were asked to check one\*

**After-school programming:** 12.38%

**Summer learning camp (a six-week summer educational program):** 20.48%

**Learning loss bridge camp (a four-week educational program conducted each year before the beginning of the school year):** 11.90%

**Tutoring:** 46.19%

**Other:** 9.05%

#### Some of the most common “Other” responses:

- Every respondent who responded “Other” suggested the most impactful way to combat learning loss is paying teachers more for the additional time and interventions they are doing to combat learning loss, or hire additional interventionists who can take from teachers those additional responsibilities.



## How are you measuring student progress in response to the above strategies? \*Respondents are asked to check all that apply\*

**State-adopted benchmark assessment:** 60.95% (+43.30%)

**Pre-test/post-test developed by educators in my school and/or district:** 40.48% (-6.58%)

**Pre-test/post-test developed by outside vendor:** 39.52% (+15.99%)

**Other:** 7.62%

### Some of the most common “Other” responses:

- “Other” responses included multiple benchmark assessments like CASE 21, iReady and NWEA MAP.



## How were these progress reports messaged to parents/guardians?

\*Respondents are asked to check all that apply\*

**Weekly personalized reports: 28.10% (+4.57%)**

**Daily personalized reports: 2.86% (+2.86%)**

**Pre-test assessment and post-test assessment reports: 67.14% (+20.08%)**

**Other: 21.90% (-7.51%)**

**Nationally, over 70% of schools are seeing an increase in the number of students seeking mental health services compared to pre-pandemic. Is this trend true for your schools as well?**

**Yes, we have also seen an increase in the number of students needing mental health services: 88.10%**

**No, we have not seen much of a change in the number of students needing mental health services since before the pandemic: 11.90%**

**If you answered “yes” in the previous question, are you able to effectively meet the needs of all students?**

**Yes, we have a robust team of mental health professionals ready to respond to student needs: 12.86%**

**Somewhat, although we have a team of mental health professionals ready to respond to student needs, it is often difficult to staff these positions: 31.90%**

**Not really, the needs have been too great and we are not able to hire the right staff to support the increase in student need: 55.24%**
