## DISTRICT LEADERS SURVEY 2017

A TennesseeCAN Statewide Poll



146 surveys were administered in late July/early August 2017 via emailed survey to all current Tennessee Directors of Schools.

69 respondents (47.26%) +0.66%\* answered the survey: 146 email addresses found, 0 bounce-back, 4 opt-out.


- 1. We continue to engage a greater number of district leaders from across the state representing a diverse set of districts.
- 2. The majority of district leaders perceive the state of education in Tennessee is improving than compared to 2016.
- 3. Budget and Staffing continue to be the largest perceived impediments to student success, though Scheduling has increased compared to 2016.
- 4. The majority of district leaders believe that teachers do not have enough time in their day and school year to meet student needs, and the vast majority of district leaders would support extending the school day and/or year if given the necessary resources to do so.

- 5. Half of district leaders now support removing mandatory class-size restrictions, an increase compared to 2016.
- 6. The vast majority of district leaders do not believe they have adequate resources to build and maintain adequate facilities, though this number decreased slightly compared to 2016.
- 7. The vast majority of district leaders do not believe they receive adequate funding for special needs students.
- 8. The majority of District leaders support the idea of weighting funding based on student need for at-risk categories of students, though many respondents were "unsure" or noted that they needed more information to decide.






Do you have the resources and support to build and maintain adequate facilities?




Would you support removing class-size mandates in order to receive more funding flexibility?\*


Do you agree that teachers and schools have enough time in their day to meet the needs of our students?\*


