

2019 District Leaders Survey





143 surveys were administered in August 2019 via emailed survey to all current Tennessee Directors of Schools.

- ullet 66 out of 143 answered the survey (46.15%/+3.00%)*
- 143 emails found | 2 email bounce-back | 1 opt out

^{*+/-} numbers show 2019 compared to 2018 results, reflected as a percent increase or decrease year over year.

KEY TAKEAWAYS:

- We saw a large increase in 2019 of district leaders' perception of the state of education in Tennessee with nearly 70% viewing it as good or excellent.
- Nearly 94% of district leaders identified Budget as a constraint to improving student outcomes—a sizeable increase compared to 2018.
- Over 60% of district leaders believe the school funding formula, the BEP, should be altered or overhauled completely, though 25% of respondents were unsure whether changes were needed. Not a single respondent thought it should remain the same as it is now.
- Further, over 40% of district leaders would support a funding formula that would weight funding based on student-need, with a sizeable percentage of respondents being unsure.
- We saw sizeable increases in the percentage of district leaders who have piloted/implemented student-based budgeting or have actively considered implementing student-based budgeting.
- We saw a 7% increase in the number of district leaders that would support removing class-size mandates if given additional funding flexibility, with the overall percentage nearing 50%.
- Nearly 60% of district leaders would support an extended school year or day, though this percentage decreased from 2018.

Overhaul the BEP completely and create a new school funding formula: 31.25% (-11.89%)

Unsure: 25.00% (+15.20%)

- Fully fund all staffing positions
- Lack of fairness between counties with differing local wealth
- "The framework of the BEP needs to be revised... The world has changed in 27 years and the bones of the formula has not. Transparency and simplicity is a must..."
